

Office Memorandum

Health Policy and Quality assurance division received feedbacks from State Health Agencies regarding issues faced in booking additional units for blood transfusion and blood component transfusion having procedure codes MG074A and MG074B respectively as fresh pre auth has to be raised every time.

2. To address this issue a new feature of number of units (1 to 4) is introduced in the Transaction Management System (TMS) which can be booked as implant. This feature will facilitate Empaneled health care providers (EHCPs) to book up to 4 units of blood and related components. This feature is currently live on Transaction Management System (TMS).
