Subject: Guideline to block ICU and HDU packages under ABPMJAY Scheme

In reference to ICU medical Procedures being blocked by Empanelled Hospital, as you are aware ICU and HDU ward (package) is part of General Medicine specialty in Hospital empanelment Portal (HEM). Many empanelled Hospital have not declared about ICU /HDU facility in their application during Hospital empanelment in HEM portal or have marked "NO" against such facilities. Despite this they are raising preauthorization/enhancement for treatment in ICU/HDU. Such Hospitals are not authorized to block ICU/HDU packages under the scheme. This act of particular hospitals is against the guideline of the scheme and should not be practiced by any empanelled hospital under ABPMJAY scheme.

In view of the above, Empanelled Hospital under ABPMJAY in State of Uttar Pradesh are directed to upload the screenshot of HEM portal, where it is mentioned that Hospital has declared ICU facility during empanelment application and same has been approved by District and State Empanelment. (Detail step take and upload screenshot is mentioned below)

Implementation support agency and Medical Committee of SHA is authorized to raise query in TMS PORTAL, requesting concerned hospital to upload aforementioned screenshot against the blocked ICU/HDU case (if not uploaded by empanelled hospital), in order to establish that Hospital is authorized to block ICU/HDU package.

Implementation support agency and Medical Committee of SHA is authorized to REJECT the pre-auth request and Claim where aforementioned screenshot of HEM portal is not available even after demanding the required screenshot of HEM portal or Hospital is not authorized to block the ICU /HDU package as per provided screenshot.

Steps to take required screenshot of HEM portal are as follows:

Step: 1- Open HEM PORTAL (https://hospitals.pmjay.gov.in), enter user credentials, already available with the Hospital, in box present on right side of the page.

- Hospital ID against Hospital / Lab Reference Number * textbox and
- Password against Password * text box.

Step: 2- Click on Civil Infrastructure Tab, under WARD Box - Status of general ward, HDU ward and "Existence of ICU with AC" is mentioned. Take screenshot of this page. Ensure Hospital ID mentioned on top right corner of the screen is also captured while taking screenshot of the page. If status of HDU and Existence of ICU with AC is mentioned as "NO". It means hospital is not authorized to BLOCK ICU/HDU packages under the ABPMJAY Scheme. (Sample of Screenshot is enclosed)

Step: 3 - Upload this screenshot in TMS portal for every ICU package blocked or in case of enhancement by the empanelled hospital for beneficiaries requiring treatment under ICU ward or HDU ward.

Hospital not abiding aforesaid guideline related to blocking of ICU/HDU packages shall be dealt further as per suspension and de-empanelment guideline of scheme.



Step: 3 - Upload this screenshot in TMS portal for every ICU package blocked or in case of enhancement by the empanelled hospital for beneficiaries requiring treatment under ICU ward or HDU ward.

Hospital not abiding aforesaid guideline related to blocking of ICU/HDU packages shall be dealt further as per suspension and de-empanelment guideline of scheme.
